



Accessibility Plan

Date for Next Review: February 2028

This policy has been written with the underlying principles of a Church of England school, which applies to North Cadbury C of E Primary School.

1. This Accessibility Plan has been drawn up in consultation with the Local Authority, pupils, parents, staff and directors/governors of the school.
2. We are committed to providing a fully accessible environment which values and includes all pupils, staff, parents and visitors regardless of their education, physical, sensory, social, spiritual, emotional and cultural needs. We are committed to challenging negative attitudes about disability and accessibility and to developing a culture of awareness, tolerance and inclusion.
3. The Trust and School plans, over time, will increase the accessibility of provision for all pupils, staff and visitors to the schools. The Accessibility Plan will contain relevant actions to
 - Improve access to the **physical environment** of the schools within the Trust, adding specialist facilities as necessary. This covers improvements to the physical environment of the schools and physical aids to access education.
 - Increase access to the **curriculum** for pupils with a disability, expanding the curriculum as necessary to ensure that pupils with a disability are as, equally, prepared for life as are the able-bodied pupils; (If a school fails to do this, they are in breach of the DDA). This covers teaching and learning and the wider curriculum of the schools such as participation in after-school clubs, leisure and cultural activities or school visits. It also covers the provision of specialist **aids and equipment**, which may assist these pupils in accessing the curriculum.
 - Improve the delivery of **written information** to pupils, staff, parents and visitors with disabilities. Examples might include handouts, timetables, textbooks and information about the school and school events. The information should be made available in various preferred formats within a reasonable time frame.
5. Attached are Action Plans, relating to these key aspects of accessibility. These plans will be reviewed and adjusted on an annual basis. New Plans will be drawn up every 3 years.
6. We acknowledge that there is a need for ongoing awareness raising and training for staff and governors in the matter of disability discrimination and the need to inform attitudes on this matter.

- The Accessibility Plan should be read in conjunction with our other policies, strategies and documents.
7. It may not be feasible to undertake some of the works during the life of this first Accessibility Plan and therefore some items will roll forward into subsequent plans.
 8. As curriculum policies are reviewed, a section relating to access will be added to that on Equality and Diversity. The terms of reference for all governors' committees will contain an item on "having regard to matters relating to Access".
 9. The Schools Prospectus will make reference to this Accessibility Plan.
 10. Information about our Accessibility Plan will be available to Parents
 11. The Plan will be monitored by the Local Governing Bodies of the schools.
 12. The schools will work in partnership with the local education authority (*and Diocesan Authority, where appropriate*) in developing and implementing this plan and will adopt in principle the Somerset Accessibility Strategy, Access to Learning.
 13. The Plan will be monitored by Ofsted as part of their inspection cycle.

Improving the Physical Access at North Cadbury C of E Primary School

It should be noted that North Cadbury C of E Primary School is housed in a Victorian building that is 150 years old, alongside a 'temporary' classroom hut that provide a constant challenge for the physical accessibility of the building.

An Access Audit is carried out by the School Business Manager, Head Teacher, Site Manager and the Trust H & S lead at regular intervals resulting in recommendations:
